Mattresses, folding mattresses, mattress-pads, -protectors and -wedges, shell made of natural fibres (cotton, wool, silk) or synthetic fibres (viscose, LENZING™ Lyocell, polyester, metallized polyester, polyamide, polypropylene, polyethylene, elastane, carbon) and their blends, colour white, dope-, yarn- or piece dyed or pigment printed, quilted with PES-fibres, anti-slip treatment or Climarelle Cool®-nonwoven, partly with Dry & Soft-, Aloe Vera-, FRESCHE®, Sanitized®, Silvercare-, Ultrafresh or Greenfirst finishing; core made of polyurethane-foam (standard-, cold-, viscoelastic-, pneumatic viscoelastic- and gel-foam), dyed, marbled, partly glued, also with pocket- or bonell spring cores (DormiSpring®) or latex foam, max. height 2,5 cm, including accessories (PU-glue, zipper, label, turning-loop, sewing- and quilting yarn, wadding, plastic accessories, velcro tape, polypropylene nonwoven, binding-, climate- and elastic tape, cord); partly produced with biological active products or fibres accepted by OEKO-TEX®; produced by using materials certified according to STANDARD 100 by OEKO-TEX®.


The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 4, **product class I** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 4 for baby articles.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.

The certificate A14-0492 is valid until 30.09.2022
